Likewise, selected companies engage themselves to **arrange business meetings** with exhibitors from 10th October to 2nd November 2023 through the web platform. Two days attendance are compulsory.

Industries

Reference sectors: complete waste cycle and recovery of all types of waste, waste management and classification software.
